ARTICLES OF ORGANIZATION OF ACCESSO EQUITY 2, LLC

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Revised Florida Limited Liability Company Act. Chapter 605. Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is ACCESSO EQUITY 2, LLC (the "Company").
