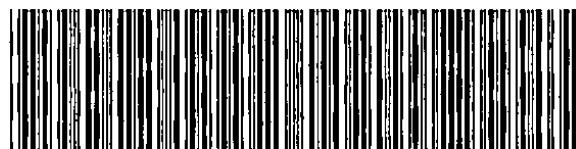


I also enclose our check in the amount of \$25.00 for the conversion fee.


