ARTICLES OF ORGANIZATION OF TCJ ENTERPRISES LLC

The undersigned, pursuant to the provisions of Chapter 605, Florida Statutes (the "Florida Revised Limited Liability Company Act"), for the purpose of forming a limited liability company under the laws of the State of Florida does set forth the following:

- 1. <u>NAME</u>. The name of the limited liability company is TCJ Enterprises LLC (hereinafter referred to as the "Company").
- 2. <u>PERIOD OF DURATION.</u> The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:
 - (i) Dissolution of the Company pursuant to the provisions of the Florida Revised
 Limited Liability Company Act; or
 - (ii) By the mutual written agreement of the Members holding a majority of the total outstanding membership interests in the Company; or
 - (iii) As provided for in a written Operating Agreement (the "Operating Agreement") executed by all of the members of the Company (each a "Member" and, collectively, the "Members").
- 3. <u>PURPOSE.</u> The purpose for which the Company is organized is to engage in any and all lawful businesses and activities permitted to be carried on by limited liability companies under the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

- 4. <u>ADDRESS OF PLACE OF BUSINESS.</u> The street address and mailing address for the Company is 9027 Eagles Ridge Drive, Tallahassee, Florida 32312. Such addresses may be changed from time to time as provided in the Operating Agreement.
- 5. **REGISTERED AGENT.** The initial registered agent in Florida for the Company is Thomas Joiner and the initial registered office is located at 9027 Eagles Ridge Drive, Tallahassee, Florida 32312.
- 6. <u>MEMBERS.</u> The Company shall have at least one (1) Member. The Operating Agreement shall set forth the rights, duties and obligations of the Members and the manner in which new Members may be admitted to the Company.
- 7. <u>CONTINUITY OF BUSINESS.</u> Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members (if any) of the Company, except as expressly provided otherwise in the Operating Agreement.
- 8. MANAGEMENT. The management of the Company shall be by and through its Member(s). The Member(s) may (but are not required to) appoint one (1) or more Manager(s) of the Company. Any such Manager(s) shall be appointed by the Member(s) and shall have the power and responsibilities provided for in the Operating Agreement. The initial Manager shall be Thomas Joiner. The initial Manager shall serve until the earlier of: (i) his death or incapacity; or (ii) his resignation. Any successor Manager(s) shall serve upon the terms and conditions provided for in the Operating Agreement.

9. <u>INDEMNIFICATION.</u> Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member or former Member to the full extent permitted under the Florida Revised Limited Liability Company Act.
