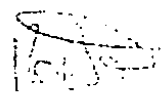

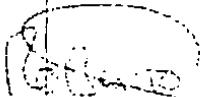

ARTICLE VIII CAPITAL CONTRIBUTIONS

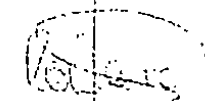
Capital contributions in the amount of \$1,000.00 cash shall be paid to the limited liability company by the two members in the following amounts:
