

**ARTICLES OF ORGANIZATION
OF

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, does hereby certify and adopt these Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **FREEDOM SHIELD, LLC** ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office of the Company shall be 2779 Gulf Breeze Parkway, Gulf Breeze, Florida 32563, and the street address of the principal office of the Company shall be 712 Hazel Drive, Fort Walton Beach, Florida 32547.

ARTICLE III – DURATION and PURPOSE

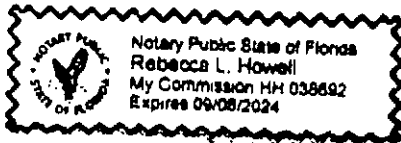

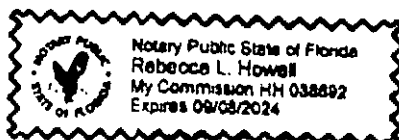
