**ARTICLES OF ORGANIZATION  
OF DENA G, LLC  
a Florida limited liability company**

The undersigned, SHERYL A. JACKSON, competent to contract and an authorized representative of DENA G, LLC, hereby presents these Articles of Organization as the Articles of Organization of DENA G, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is DENA G, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**
