
**ARTICLE VI

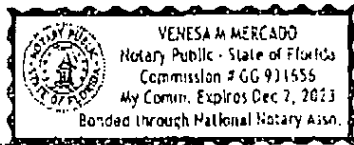



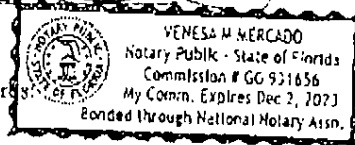
