4. Place of Principal Office. The mailing and street address of the Company's principal office is 211 Durango Road, Unit 311, Destin, Florida 32541.

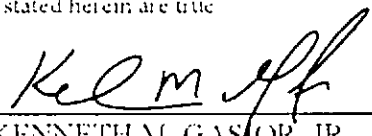
