**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

Article I. Name

The name of the limited liability company is Backyard Living, LLC.

Article II. Filing

The Articles of Organization of the limited liability company were filed on February 17, 2023, and were assigned Document Number L23000078177 (EIN is 92-2434897).

Article III. Amendments

The following amendments to the Articles of Organization were adopted by the limited liability company:

1. **ARTICLE III** of the Articles of Organization is deleted in its entirety and replaced with:

**“ARTICLE III
MAILING ADDRESS; PRINCIPAL OFFICE**

The address of the principal office and the mailing address of the Limited Liability Company shall be 7780 49th Street North, #104, Pinellas Park, Florida 33781, and such other places as may be designated by the Manager from time to time.”

2. **ARTICLE VI** of the Articles of Organization is deleted in its entirety and replaced with:

**“ARTICLE VI
MANAGEMENT**

The Limited Liability Company shall be a manager-managed limited liability company. The authority, and limitations on such authority, of the Manager(s) shall be specified in the Operating Agreement of the Limited Liability Company. The Manager of the Limited Liability Company, and the address of said Manager, shall be Redwood Patio, LLC, whose mailing address is 7780 49th Street North, #104, Pinellas Park, Florida 33781.”
