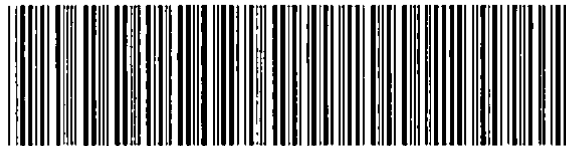

ARTICLES OF CONVERSION

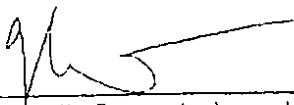
ARTICLES OF ORGANIZATION

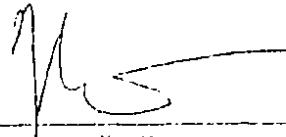
