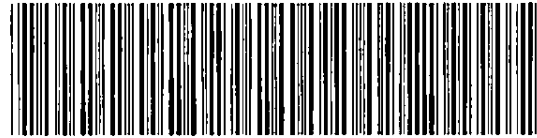

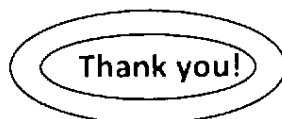

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act ("Act"), these Articles of Merger, which relate to the merger (the "**Merger**") of Absolute Investment Advisers LLC, a Massachusetts limited liability company (the "**Non-Surviving Entity**"), with and into Absolute Investment Advisers, LLC, a Florida limited liability company (the "**Surviving Entity**"), provides as follows:




