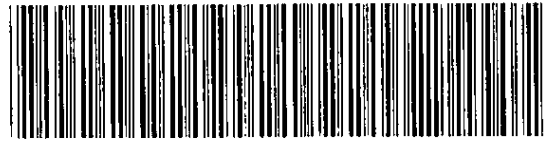

**ARTICLES OF ORGANIZATION  
OF  
TNP VENTURES, LLC**

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes, as follows:

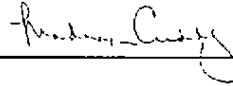
## ACCEPTANCE OF REGISTERED AGENT
