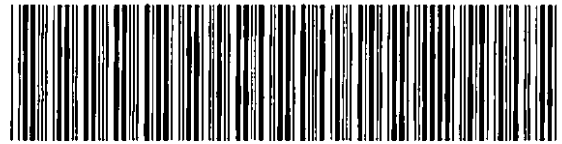

The name of the Florida Limited Liability Company is **Coad Red LLC**.


**Article II**


