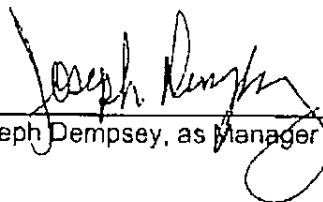
1. The Articles of Organization for 6655 CLAIRBORNE LANE, LLC were filed on March 9, 2023 and assigned document number L23000109662.
