**ARTICLES OF ORGANIZATION
OF
SALT STUFF ISLAND, LLC**

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME & ADDRESS**

The name of this limited liability company shall be SALT STUFF ISLAND, LLC (the "Company") and its principal office address and mailing address is 3333 W. Kennedy Blvd., Suite 206, Tampa, Florida 33609.

**ARTICLE II
EFFECTIVE DATE**




