# ARTICLES OF ORGANIZATION OF GRIFFIN CAPITAL HOLDINGS, LLC

The undersigned, acting as the organizer of a limited liability company to be formed under the Florida Limited Liability Company Act. as amended (the "Act"), hereby forms a Florida limited liability company (this "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (these "Articles"):

### ARTICLE I Name

The name of this Company shall be: GRIFFIN CAPITAL HOLDINGS, LLC

#### ARTICLE II Flace of Business

The principal place of business and mailing address of this Company shall be 509 North Tampa Street, Unit 2A, Tampa, Florida 33602, and such other place or places as may be designated by the managers from time to time.

#### ARTICLE III Registered Agent and Office
