**ARTICLES OF ORGANIZATION
OF
ZEDA TECHNOLOGY, LLC**

1. Name. The name of this limited liability company is **ZEDA TECHNOLOGY, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The street and mailing address of the Company's principal office is **3230 Anchor Bay Trail, Bradenton, Florida 34211.**

6. Purpose; Operating Agreement. 
