**ARTICLES OF ORGANIZATION  
OF  
VITALITY RENEWED, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I  
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **VITALITY RENEWED, LLC**.

**ARTICLE II  
ADDRESS**

The Company's street address of its principal place of business in Florida is 40 Killarney Avenue, Saint Johns, Florida 32259, and its mailing address is the 362 Gulf Breeze Parkway, #210, Gulf Breeze, Florida 32561, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.

**ARTICLE III  
MANAGEMENT**

The business of the Company shall be managed by a Manager selected by the Members. The initial Manager shall be **Monica Jaqueline Mills** whom shall serve as a Manager of the Company until her resignation or death, or as otherwise provided in the Operating Agreement of the Company.

New members may only be admitted as provided in the Operating Agreement of the Company. A member's interest in the Company may only be sold or transferred as provided in the Operating Agreement of the Company.

AMENDMENT TO ARTICLES**

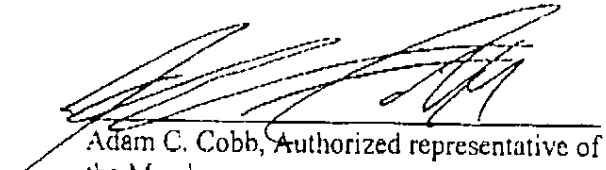

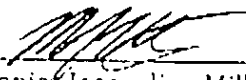
