ARTICLES OF ORGANIZATION
of
JACKSONVILLE BEACH MEDICOLEGAL REVIEWS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Jacksonville Beach MedicoLegal Reviews, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 3097 South Ponte Vedra Boulevard, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 
