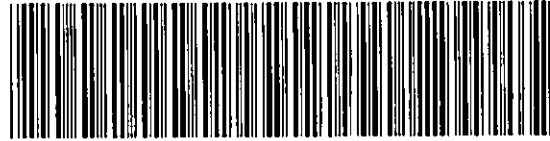



ARTICLE VII


MEMBERS RIGHTS TO CONTINUE BUSINESS
