**ARTICLE I**

The initial member of the Company shall be **DAWN WALLNER**.



## MANAGEMENT

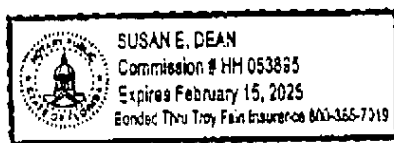


