**ARTICLES OF ORGANIZATION  
OF

The undersigned William A. Lovell, Jr., a natural person competent to contract and an authorized representative of Carson Lovell Arizona, LLC, hereby presents these Articles of Organization as the Articles of Organization of Carson Lovell Arizona, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Carson Lovell Arizona, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE V - REGISTERED OFFICE AND AGENT**




