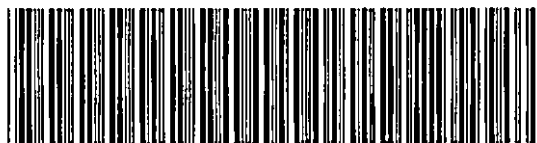

**ARTICLES OF ORGANIZATION  
OF

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 and 621, *Florida Statutes*, do hereby certify as follows:

**ARTICLE I  
NAME**

The name of the limited liability company is **LAW OFFICES OF MORGAN WHITE-DAVIS, PLLC** (the "Company").

**ARTICLE II

**ARTICLE VII

The Company will not be dissolved upon the retirement, resignation or expulsion of a Member, or any other occurrence which terminates a Member's membership in the Company, unless the Members, other than the affected Member, vote unanimously that the Company be dissolved and liquidated.

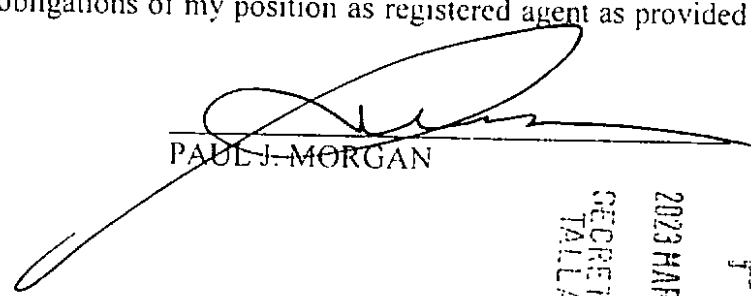

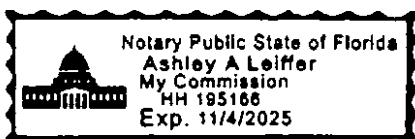

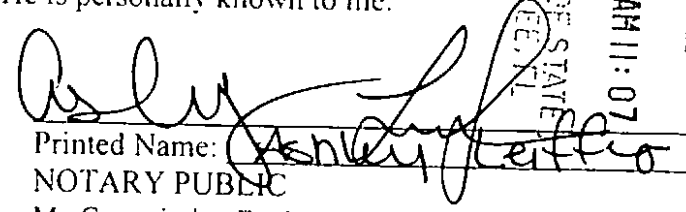
