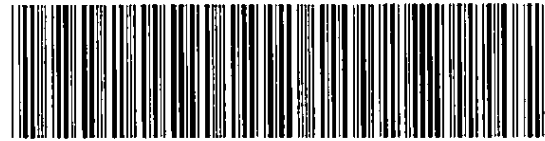

ARTICLES OF ORGANIZATION OF BIG CLAW REAL ESTATE, LLC

The undersigned, acting as the manager of BIG CLAW REAL ESTATE, LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

The name of the Company shall be Big Claw Real Estate, LLC.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 401 Gulf Blvd, Indian Rocks Beach, Florida 33785.

ARTICLE III: DURATION AND PURPOSE




