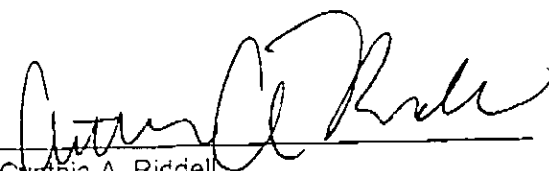
1. **Name**. The name of the limited liability company is: VENICE ISLAND, LLC.
