#### Plan of Domestication

- 1. This Plan of Domestication (this "Plan") is made for the purpose of converting Basement Defender, LLC, an Illinois limited liability company (the "Domesticating Entity"), into Basement Defender, LLC, a Florida limited liability company (the "Domesticated Entity").
- 2. Upon adoption of this Plan by the managers and members of the Domesticating Entity, the Domesticating Entity will file (i) with the Illinois Secretary of State, an Illinois Form EOA 305, "Statement of Domestication;" and (ii) with the Florida Department of State, both (a) Florida "Articles of Organization" for the Domesticated Entity, and (b) Florida "Articles of Domestication."
