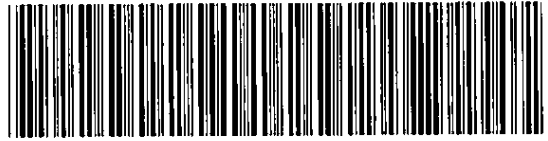

**ARTICLES OF ORGANIZATION
OF
THE PERSEVERING COMPANY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is The Persevering Company, LLC (the "Company").

The mailing address and street address of the principal office of the Company shall be 66 W. Flagler St., Suite 500, Miami, Florida 33129.

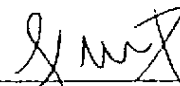
ARTICLE III. REGISTERED AGENT AND OFFICE
