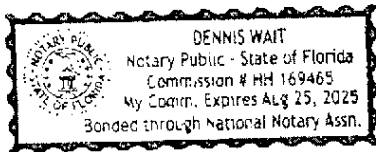
Daniel Callahan, being duly sworn deposes and states as follows under penalty of perjury:
