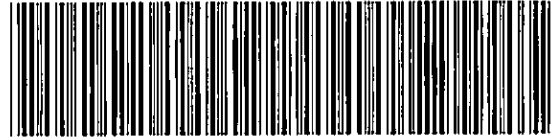

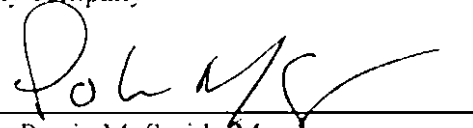
1. The name of the "Other Business Entity" immediately prior to the filing of these Articles of Conversion is Porsh Smith Photography Inc.

The mailing address and street address of the principal office of the Company shall be 15532 SW 171 Street, Miami FL 33187.

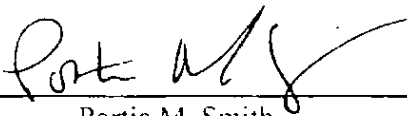
ARTICLE III. REGISTERED AGENT AND OFFICE
