**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
EVERYCHARGE, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **EVERYCHARGE LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, as amended, *Florida Statutes* § 605.0202:

1. Name of Company. The name of the Company is **EVERYCHARGE, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State with an effective date of April 11, 2023, as amended on April 25, 2023 (the "Articles").
3. Amendment to Articles of Organization. Section 4. of the Company's Articles is hereby amended by deleting the current text of Section 4. in its entirety and substituting the following in lieu thereof:
