ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I
NAME

The name of the limited liability company shall be BODHI 1810 HOLDINGS, LLC (the "Company").

ARTICLE II
MAILING ADDRESS

ARTICLE III

ARTICLE VI STREET ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of the Company shall be located at 9005 SW 68 Avenue, Pinecrest, Florida, 33156, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.
