ARTICLE III - MANAGEMENT

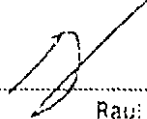

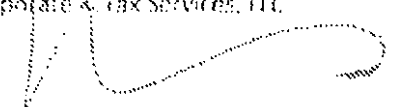
