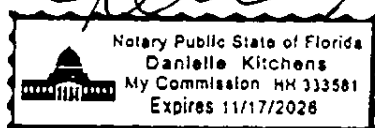
ARTICLE VI**Operating Agreement**



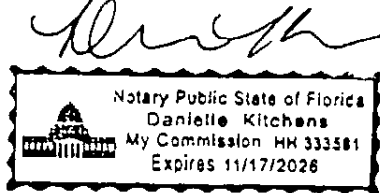


