**ARTICLES OF ORGANIZATION
FOR
TRAPEZOID INVESTMENTS, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of TRAPEZOID INVESTMENTS, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is TRAPEZOID INVESTMENTS, LLC.

**ARTICLE II
INITIAL PRINCIPAL OFFICE**

**ARTICLE III


