





SHAREHOLDERS' RESOLUTION OF AMERICAN RESTAURANTS INVESTMENT CORPORATION

RESOLVED, that the CORPORATION has not intent to file revocation of dissolution of AMERICAN RESTAURANTS INVESTMENT CORPORATION.

RESOLVED, that this resolution from the members of the CORPORATION becomes effective immediately.
