**Article I
Name**

The name of the limited liability company ("Company") is **SAFE HARBOR BOAT STORAGE, LLC**.

**Article II
Address**

Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

Any additional members are allocated gain, loss, income or expense by the method provided in the Operating Agreement of the Company, and if no method is specified, then as may be permitted by the Internal Revenue Code of 1986, as amended.


