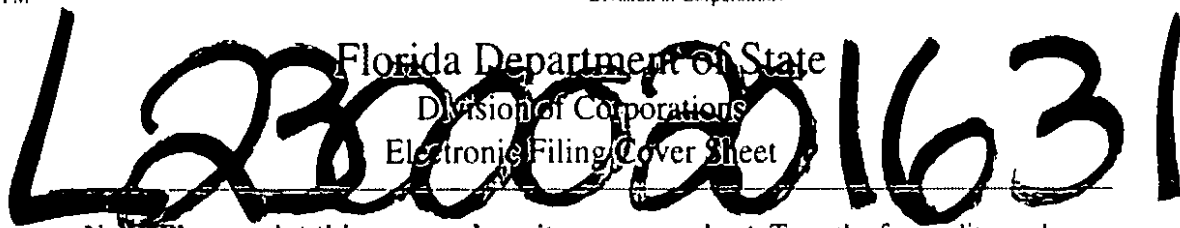

ARTICLES OF ORGANIZATION

Pursuant to the authority of the Florida Revised Limited Liability Company Act, Chapter 605, Fla. 
