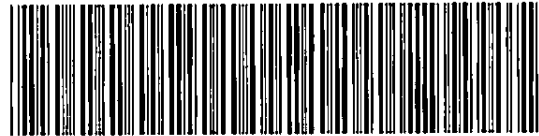




1. Name of the Company. The name of the limited liability company (hereinafter referred to as the "Company") is BKKS Holdings, L.L.C.
