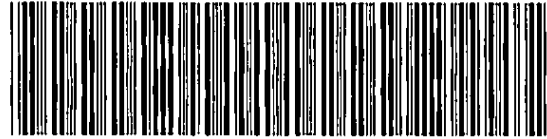

1. The current name of the Company is MHP Bayonet Elderly Developer, LLC.
2. The original Articles of Organization of the Company were filed with the Florida Department of State on April 24, 2023, with an effective date of April 19, 2023, and assigned document number L23000202108, as amended pursuant to those certain Articles of Amendment to Articles of Organization of the Company filed with the Florida Department of State on August 19, 2024 (as amended, the "**Articles**").
3. The Articles are amended by deleting Article VI in its entirety and replacing it with the following:
