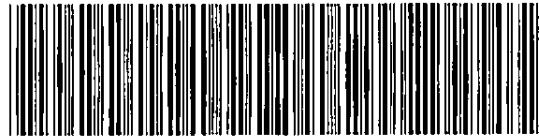

THIRD: The mailing and street address of the principal office of the Limited Liability Company is 8466 Karwick St, Orlando, FL 32836.


