**ARTICLES OF ORGANIZATION
OF

The undersigned, Kimberly Mathes Cheney, a natural person competent to contract and an authorized representative of Mathes Group Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of Mathes Group Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is Mathes Group Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The address of the initial principal office is 6 West 41st Lane, Pensacola, FL 32505, and the initial mailing address of the Company is P.O. Box 9699, Pensacola, FL 32513. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS




