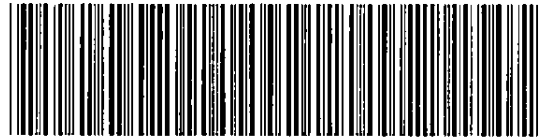

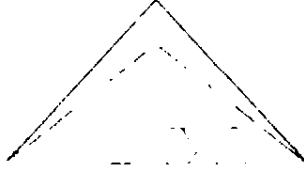

I am sending this letter to request for our LLC name to be changed as follows:


Current name: Level Up Dance Studio LLC
