**ARTICLE V - INITIAL REGISTERED AGENT**

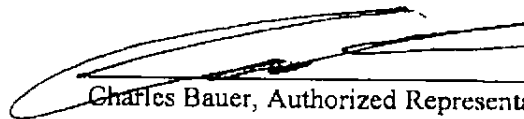
