MANAGEMENT

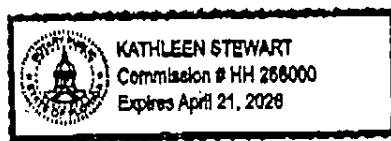


