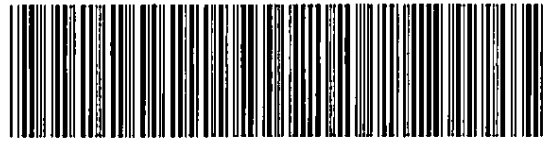

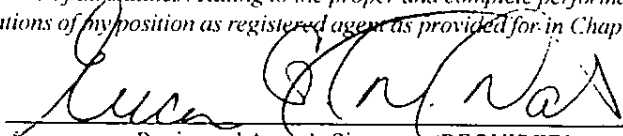

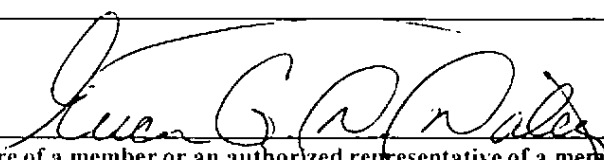

I was informed in order to maintain the same corporate name I had to:

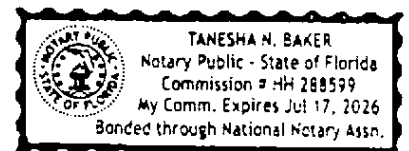
1. **Dissolve B&E INVESTMENT CONSORTIUM, INC.**
