**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

Pursuant to the provisions of Section 605.0202, Florida Statutes, DOGWOOD DEVELOPMENT GROUP, LLC, a Florida limited liability company (the "Company"), hereby adopts the following amendment to its Articles of Organization:

1. The name of the Company is DOGWOOD DEVELOPMENT GROUP, LLC.
2. The Articles of Organization of the Company were filed on May 1, 2023 and assigned document number L23000215300.
3. Article II of the Articles of Organization is hereby amended in its entirety and replaced with the following:

**"ARTICLE II – ADDRESS**

The initial address of the principal office and the initial mailing address of the Company is 5130 Pirates Cove Road, Jacksonville, FL 32210."


4. Article IV of the Articles of Organization is hereby amended in its entirety and replaced with the following:

**"ARTICLE IV – MANAGEMENT OF THE COMPANY**

The Company is to be managed by one manager and is, therefore, a manager-managed company. The initial Manager of the Company is MARYANNE FRANCES L. JOHNSON."

5. Except as amended hereby, the Articles of Organization of the Company shall remain in full force and effect.
