ARTICLES OF ORGANIZATION

- A. The name of the limited liability company is SIC Lifestyle, LLC (the "Company").
- B. The Articles of Organization of the Company were filed with the Florida Secretary of State on May 2, 2023, and assigned Florida document number L23000217847.
- C. The Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

**"ARTICLES OF ORGANIZATION

The undersigned organizer, who is the authorized representative of SIC Lifestyle, LLC (the "Company") under the Florida Revised Limited Liability Company Act, hereby adopts the following Articles of Organization.

**ARTICLE I - NAME**

**ARTICLE II - PRINCIPAL OFFICE**
