The initial registered agent of the Company is DAVID M. BEAR, and the initial address for that registered agent is 4941 Pattock Place, Pace, Florida 32571.

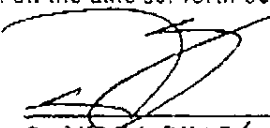
ARTICLE VI - MANAGEMENT

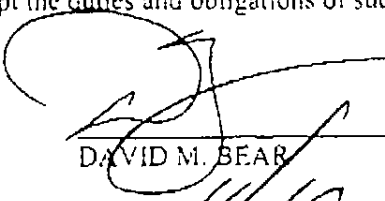
