ARTICLES OF ORGANIZATION **GNOSIS GROUP LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the

ARTICLE 1 - NAME

The name of the limited liability company shall be GNOSIS GROUP LLC.

ARTICLE 2 – ADDRESS

ARTICLE 5 - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any and all lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE 6 - REGISTERED AGENT AND REGISTERED OFFICE

ARTICLE 7 - ADMISSION OF NEW MEMBERS
