**ARTICLES OF ORGANIZATION  
OF

The undersigned, HAROLD R. HUDSON and SUELLEN A. HUDSON, natural persons competent to contract and an authorized representative of HUDSON OKALOOSA, LLC, hereby present these Articles of Organization as the Articles of Organization of HUDSON OKALOOSA, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is HUDSON OKALOOSA, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial mailing address and principal address of the Company is 2109 Bayou Boulevard Pensacola, Florida 32501. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

**ARTICLE V - REGISTERED OFFICE AND AGENT**

**ARTICLE VI - MANAGEMENT**

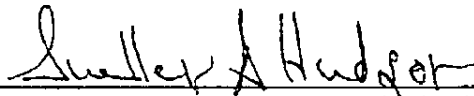
